Current Affairs Related to 3rd March 2025

- ♠ IndusInd Bank has officially announced a partnership with the Professional Golf Tour of India. This includes providing assistance to ultra high net worth individuals to better tailor their MBA experience under the Pioneer Program. This includes partnering with premium banking services in the sports sector of the self-owned IndusInd Bank.
- India has made significant progress in urban sanitation and waste management, through which new standards of freedom are being set through the Freedom Survey. The 9th edition of Slider Surveyor 2024, launched by Union Minister of Housing and Affairs Manohar Lal Packet, introduced a new format to ensure assistance estimates. This year the concept of Superselect League was introduced, which includes cities that have excelled in constant cleanliness in the last three years.
- India has achieved a historic achievement in the field of Ayurveda and holistic health care and has won five Guinness World Records under the Desh Ka Prakriti Pariksha Abhiyan. The first phase of this campaign took place in Mumbai in collaboration with the National Commission for Indian System of Medicine and the Ministry of AYUSH. This initiative has contributed significantly in connecting Ayurveda with public health and promoting a data driven approach in health care.
- NITI Aayog has constituted a committee to include AIIMS New Delhi as a leading medical research and healthcare institution globally. This committee is headed by NITI Aayog member VK Paul. The committee has prepared a clear incomplete proposal for assessing the current system and improving it. This is a first and is part of a comprehensive plan to promote wholesale, administration and self-reliance of healthcare services in India.

- Jan Bhaagidari Sahyog Marketing Development Corporation, which comes under the Ministry of Tribal Affairs, has signed important MoUs with National Institute of Fashion Partnership Marketing and Himachal Pradesh Horticultural Product Marketing and Corporation Limited. The event was held during the Aadi Mahotsav program held in New Delhi. It aims to transform mass cultural marketing from a business to business model to a business to business model.
- ↑ The Securities and Exchange Board of India has imposed a fine of 10 lakhs on Axis Securities, as the company committed several violations of stockbroker rules. This action has been taken after inspection for the period from April 2021 to November 2022. SEBI highlighted violations of rules by Axis Securities, improper management of client funds and deficiencies in grievance redressal.
- ♦ Sunil Bharti Mittal, founder and chairman of Bharti Enterprises, has been awarded honorary knighthood for his contribution to strengthening India UK trade relations. He was conferred the title of Knight Commander of the Most Excellent Order of the British Empire at a special ceremony held at the residence of the British High Commissioner. This honor was given under the reign of King Charles III, making Mittal the first Indian citizen to receive this title.
 - The Indian group has achieved a historic feat by preparing the first detailed geological map of the South Pole of the Moon using the data of the Chandrayaan-3 mission. This new map provides important information about the topography of the lunar surface, the formation of the monument and the geological history. In this research, the help of Physiology Research, Punjab University and ISRO's Electro Australian System Tool was taken, which gave a major breakthrough in understanding the evolution of the moon.
- Nature 2025, was organized in New Delhi. This institution is under the Bureau of Energy Efficiency, Ministry of Power, in which more than 600 builders have participated. The objective of this conference was to develop a protected carbon market in India, so that the country can move towards low carbon industry.
