Current Affairs Related to 7th March 2025

- SEBI launched Partal Bond Central, a centralized database for corporate bonds. Its main objective is to create a single platform for authentic sources of information on corporate bonds issued in India. It will act as an information repository for the general public and can be accessed free of cost. This database will increase transparency and help investors and other market participants in decision making. It will be operated by the Online Bond Platform Providers Association.
- ♦ IndusInd Bank has officially announced a partnership with the Professional Golf Tour of India. It provides assistance to ultra high net worth individuals to better tailor their MBA experience under the Pioneer Program. This includes the partnership of the self-owned IndusInd Bank with premium banking services in the sports sector.
- India and Bangladesh held the biennial Teacher Star Dialogue Collaboration between Border Security Force and Border Guard Bangladesh. Important steps like strengthening border security and establishing new communication systems were taken in this three-tier meeting. In addition to the Eastern Command of the Group, a hotline will be established between Devgad and its BGB counterpart in Dhaka. This hotline will be in addition to the communication line already existing between the BSF and BGB chiefs and other officials.
- The Securities and Exchange Board of India has imposed a fine of 10 lakhs on Axis Securities, as the company violated several stockbroker rules. This action has been taken after inspection for the period from April 2021 to November 2022. SEBI highlighted violations of rules by Axis Securities, improper management of client funds and deficiencies in grievance redressal.
- The Indian group has achieved a historic feat by preparing the first detailed geological map of the South Pole of the Moon using data from the Chandrayaan-3 mission. This new map provides important information about the topography of the lunar surface, the formation of the monument and the geological history. In this research, the help of Electro Australian System Tool of Physiology Research, Punjab University and ISRO was taken, which gave a big breakthrough in understanding the evolution of the moon.

- As per the amended rules, birth certificate will be the only proof of date of birth for passport applicants born on or after 1 October 2023. The passport rules of 1980 have been amended. For persons born on or after 1 October 2023, birth certificate issued by the Registrar of Births and Deaths, Municipal Corporation or any other authority having powers under the Registration of Births and/or Deaths Act, 1969 will be accepted as proof of date of birth.
- Agriculture Minister Shivraj Singh Chouhan said that a national committee will soon be formed to promote natural farming. He emphasized on adopting natural farming. Under this, a committee will be formed at the national level to make this mission a movement. This committee will work towards increasing awareness among farmers and training them regarding adopting natural farming methods.
- Hindustan Aeronautics Limited has signed an agreement with the Pune-based Institute of Advanced Technology. It aims to promote research, skill development and innovation in aerospace technology. HAL Acquisition Academy, HAL's flagship training institute, plays a key role in this collaboration, enabling HAL officials to gain higher education, research and training of associate aerospace technicians.
 - The Ministry of Statistics and Program Implementation launched a hackathon called Innovate with GolStats. The theme of this hackathon will be data driven insights for developed India. The main objective of the hackathon is to inspire students and researchers to use the vast official data generated by the National Statistical Office to create innovative data driven insights. The hackathon will take place on the MyGov platform from February 25 to March 31. Students pursuing graduation, post graduation or research can participate in the event.
- The Uttarakhand government has presented a budget of Rs 1,01,175.33 crore for the financial year 2025.2026 under the leadership of Chief Minister Pulwama Singh Dhami. The main objective of this budget presented in the state assembly by Finance Minister Prem Chandra Aggarwal is to promote finance, public welfare and economic development, as well as to ensure financial stability.
