Current Affairs Related to 10th April

- BharatNet project is being implemented for broadband connectivity to all Gram Panchayats and villages beyond Gram Panchayats on demand basis. The revised BharatNet program, approved in August 2023, is improving the existing network. It also promotes the use of the network through BharatNet entrepreneurs. BSNL is the sole project management agency for operations and maintenance. The mission aims to accelerate the expansion of digital infrastructure and bridge the digital divide.
- Aakarsh Madam, founder of YouthSpark, was awarded the National Youth Award for her effort to promote early childhood education in India, especially through innovation in Belwadi digital integration and rural education graduation class. - Prime Minister Narendra Modi went on Kishori Yatra to attend the 6th BIMSTEC Summit. The purpose of this visit is to include regional cooperation, with special emphasis on trade, connectivity and economic assistance. The visit also includes discussions with the leaders of China, Sri Lanka and other countries. Apart from this, it highlights the growing importance of India's land area in the context of regional connectivity.
- The Jharkhand government has announced plans to conduct a caste-based census in the next financial year. The government made this announcement in response to a question by Congress MLA Pradeep Yadav. The question was raised during the budget session of the state assembly. Cabinet Minister Deepak Barua assured that the survey will be conducted in the coming financial year. The proposal for caste-based census was approved by the state government in February 2024.
- ♦ The Strengthening Multimodal and Integrated Logistics Ecosystem program funded by the Asian Development Bank has been launched with the aim of strengthening the logistics infrastructure in India, reducing logistics costs and student promotion. It supports the National Logistics Policy and Speed Power National Master Plan.

- Sohini Rajola has been appointed as Executive Director Solang in National Petroleum Corporation Limited. The role includes driving adoption of NPCI's payment solutions, improving the companies and managing partnerships with key stakeholders including companies, fintech companies. This decision is part of NPCI's growth strategy led by NPCI to accelerate its payment solutions. Rajola's vast experience in the payment and digital network realm will play a key role in further development and ideation of NPCI's solutions.
- The company approved the Finance Bill 2025 with 35 government amendments. Amajor amendment of this bill eliminates 6% digital tax on likes on the online canvas. The introduction of the Finance Bill 2025 has been completed in the House with the benefit of the financial year 2025. - The Rajya Sabha approved the Disaster Management Bill 2024. It was passed by the Lok Sabha in December 2024. The bill amends the Disaster Management Act 2005. Its main objective is to strengthen the efficient functioning of the National Disaster Management Authority and State Disaster Management Authorities. The bill empowers the NDMA and SDMA to prepare disaster plans at the national and state levels. The bill also empowers the state government to constitute a separate Urban Disaster Management Authority for state capitals and municipal cities.
 - A new e-auction portal called Banknet has been launched by the Ministry of Finance to make the listing and auction of banks' assets more efficient. Banknet was launched on 3 January 2025. The e-BKare platform was launched on 28 February 2019. The Banknet portal has been specially designed to enhance transparency and expedite the process of resolution of non-performing asset cases. It provides a quick and efficient way to apply for a loan and get approval based on digital evaluation of the applicant's data.


