



## Current Affairs Related to 3 April 2025

- ◆ **The Central Government has approved the appointment of Rahul Bhawe as Managing Director and Chief Executive Officer of IRFCI.** Prior to this, he was holding the post of Deputy Managing Director in IRFCI. His assuming office will be over three years. It has been set up by the Prime Minister's Baishakhi Dharamshala Committee.
- ◆ **In a significant achievement for Indian wrestling, Indian Wrestling President Sanjay Singh** has been elected as a Bureau Member of United World Wrestling Asia. The election was held during the New Asia General Assembly in Amman, Jordan. Sanjay Singh secured 22 out of a total of 38 votes, which includes strong support for him from the Asian wrestling community. His election will prove to be an important milestone for Indian wrestling, strengthening India's presence at the international level and giving further impetus to the development of a sport in Asia.
- ◆ **Mukesh Ambani-led Reliance Industries Limited has acquired 100% stake in Nauyan Trading Private Limited** through its wholly-owned subsidiary, Reliance Strategic Business Ventures Limited. The deal is worth Rs 1 lakh crore to Welspun Trading Limited, a subsidiary of Welspun Corporation Limited. With this acquisition, NTPL has now become a wholly-owned subsidiary of RIL. Apart from this, NTPL has signed a share purchase agreement with WCL.
- ◆ **India remains the largest milk producer in the world, currently its milk production capacity** is 239 million tonnes. Union and associate minister Rajvi Ranjan Singh announced in Norway that India is working towards achieving the target of 300 MMT milk production in the next five years. The National Gokul Mission which was started in 2014 is a major factor in this growth. India's dairy sector has grown significantly, making it contribute to more than 24% of global milk production.
- ◆ **Cricketer Dhoni and members of the Chennai Super Kings team flashed agram** in the redemption of the book Leo: The Untold Story of Chennai Super Kings, which added excitement to the tournament. The book is written by former Tamil Cricket Association vice-president P.S.C. Raman. Many well-known personalities from the world of cricket and entertainment are involved in this program.
- ◆ **Under the Pradhan Mantri Bhartiya Janaushadhi Pariyojana, 15057 Jan Aushadhi Kendras** are being opened across India. This information was shared by Union Minister of State for Chemicals and Biotechnology Smt. Anupriya Patel in a written reply on 28 February 2025 in Sagar. The objective of this scheme is to create a passport list of the best and quality generic stockists across the country. PMBJP scheme was launched. Through Jan Aushadhi, these Aushadhi brand medicines are made available at a comparatively much lower price, making it easier for health to buy medicinal medicines economically.
- ◆ **Bellatrix Aerospace, a Bengaluru-based private space company, has signed** a Memorandum of Understanding with Japan Astro Keyscale. It focuses on providing active debris removal, satellite services and promoting sustainable support in orbit. The objective of this collaboration is to ensure stability in space and keep the Earth's orbit clean. Active debris removal satellite service and sustainable orbital solutions are to be developed.
- ◆ **The company has approved the Finance Bill 2025 with 35 government amendments.** A major amendment to this bill eliminates the 6% digital tax on likes on the online canvas. The introduction of the Finance Bill 2025 has been completed in the House along with the benefits of the financial year 2025. Now this set will be considered in the museum after which the nomination will be done in the form of budget process nomination for the financial year 2025.2026.
- ◆ **Defence and Development Organisation (DRDO) and Indian Navy successfully flight tested a Vertically Launched Shortrange Surface to Air Missile (VSL).** The test was conducted at the land based vertical range at Silverpur, Odisha. The missile effectively destroyed a high speed aerial target at very deep depth and short range, thereby validating its Near Boundary Low Altitude capability.
- ◆ **In view of the increasing cases of student suicides in higher educational institutions,** the Supreme Court has constituted a National Task Force to address the mental health issues of students. The court stressed on understanding the aspects behind these incidents and developing effective solutions.


